



Council Minutes

February 12, 2024

Council members present were Karen Temple, Kay Johnson, Kay Carter, Marian Robertson, Jeff Edwards, Karen Liston, and Pastor Michael via Zoom. Terresa Lauck was also present.

Meeting was called to order by council president, Karen Temple at 5:13.

Pastor led the opening prayer.

Approval of Agenda: Kay J. moved to approve. Jeff seconded; all approved. Pastor asked if he is able to vote and the constitution says that it is permitted.

Pastor wanted to share some things before we started. It is new for him to be a part-time Pastor. He will be in Ft. Morgan from Saturday morning through Sunday after service. He will be available for needs and pastoral care. He is willing to be here for a Saturday morning Bible study. Pastor said that he is sharing his personal phone number and for us to please respect the use of it for emergencies only. He is very available by email. Pastor Michael said that with his being here through Easter, he is planning to fully be here and he is willing to do his best for LCOR. He wants us to all have good, open conversations, communicating in a respectful and loving manner with each other. Pastor shared that he is intrigued by the congregational covenans around the building and is wondering if we need a fresh one or just make sure we follow the old one. Kay C. shared that she would like to see both congregational and council covenants.

Approval of Secretary Report: Kay J. moved to accept the report. Jeff seconded; all approved.

Approval of Treasurer Report: Terresa explained each page of the report for new and existing council members. Kay C. moved to approved the report. Marian seconded; all approved.

Committee Reports:

There is nothing to report as no committee turned in a report for this month.

The Audit Committee Appointees were presented as Elsie Menken, Carol Foos, and Shelly Bristol. Karen L. moved to approved all who were listed as auditors. Kay C. seconded; all approved.

Old Business: We need to get the specifics of the grant information for the landscaping project for the outside of the building. This has been requested y Eric Walek and Rocky Ernst.

New Business:

Membership Roster- Karen T. wants a current list of members to be at the front of the annual

meeting, including the total number of members and the number needed to make quorum.

Process to review roster with the definition of a member being agreed upon- Voting members are those members who have given money and have taken communion in the last two years. This was explained directly from the Constitution.

Karen T. would like the Constitution and by-laws to be updated. Pastor shared that the synod has a model constitution that can be used as a resource. Once the material is updated, it needs to be brought to the congregation to vote on the proposed changes.

Evangelism Team- The initial thought for the Evangelism Team would be to contact people who have been members in the past and to see if they want to continue or if they want to be removed. Pastor informed council that there is a letter to be utilized for this contact that can be obtained from the synod.

Kay J. brought up the need for the team to be more involved in true evangelism activities, such as checking on members to see how they have been, see how the church can help them, etc. Pastor is willing to be on a team to make a list of questions to help with this communication. It was also suggested to ask the congregation who would be interested in serving on the Evangelism Team.

LCOR currently does have an active Card Committee. It was suggested that communication be shared between the Card Committee and the Evangelism Committee to have good communication.

Evaluation of Admin Assistant-Pastor Liliana and Karen T. met with Francie for a 90+ day evaluation. It was two weeks prior to Saturday, February 10. The purpose was to see how Francie is feeling with the position and how the job is being taken care of. Karen T. reported that the meeting was very positive and that suggestions were shared to support Francie in her position. She said that Francie is very eager to do a good job. During the evaluation the chain of command was re-established in terms of who Francie contacts about duties, decisions, and processes as they arise. The first person for contact is Pastor, then Council President, and then Council Vice President. Francie is also responsible for putting the minutes into the church binder and keeping it up to date each month. Karen T. and Pastor Michael will have and informal evaluation/conversation with Francie before Pastor Michael leaves LCOR.

Evaluation of Custodians- A date will be set by Pastor Michael and Karen T. for this conversation. The purpose is to offer support to them just as was done with Francie. It is also just good business practice to evaluate the position and not the person. Currently, the custodians are well within the budgeted hours. They are working 12 of the 24 monthly hours that had been agreed upon.

Transition Team- discussion was held on the upcoming formation of a Transition Team for LCOR. The Transition Team is to put together information about significant events in the history of LCOR, both good and bad, and also to consider how those events have shaped our church. The Transition Team also needs to be thoughtful as to who we want to be as a church in the future. The question was raised as to who should be on the team. People who are respected, not carrying agendas, and having an open spirit for working on a team and carrying out the needed duties. Council agreed to move this conversation to the agenda for the next council meeting so we can go to the ELCA website for the guidance book in order to have a quality, in-depth conversation.

Easter schedule- Pastor Michael will be willing to have services for Maunday Thursday, Good Friday, and Easter Sunday. The events planned for Easter Sunday are and Easter breakfast, and and egg hunt. Kay C. and Dave Jorgensen will meet with Pastor Michael to work out the specifics.

Other Business:

Congregation Members' Comments- Ideas and comments have been shared with council members since the last meeting. It was brought up to look at a different format for the bulletin. The thought is trying to support Francie and the use of a different style could be easier to work with. Another suggestion was brought up by a congregation member for the council to look at a calendar at the monthly meeting and have council members sign up for specific worship service duties in order to have the information in a format that might help Francie in getting people to cover the various duties. Both Pastor Michael and Karen T. said that the Francie is the person to decide what system works best for her and that she is getting more and more comfortable with the process she was trained on by Terresa. It is ultimately Francie's preference.

Another congregation member brought up concerns following the recent annual meeting. This member said that the annual meeting process needs to be followed as printed in the agenda for the meeting. Things that are not on the agenda should be taken to council to discuss prior to the annual meeting, whether it be concerns, questions, or bringing up situations from the past. The annual meeting is not the time or place and the agenda needs to be respected. After discussion it was voiced that at the beginning of the annual meeting it needs to be stated that only agenda items will be discussed.

Council Officer Elections- Kay J. nominated Karen T. for president. Kay C. seconded; all approved. Karen L. nominated Jeff for Vice President; Kay C. seconded; all approved. Kay C. nominated Karen L. for secretary. Marian seconded; all approved.

Karen T. and all of the new council want to thank Bob and Rick for their years of service and their time and diligence in fulfilling their positions when they were on church council. They are both very appreciated.
